Introduction

In November 2018 the Italian National Agency for the Evaluation of Universities and Research Institutes (ANVUR) underwent its first external review process with the aim of being included in the European Network for Quality Assurance in Higher Education (ENQA). The review took place in Rome from 20 November to 22 November 2018 and was coordinated by ENQA: the review panel consisted of 2 ENQA nominees, 1 ESU nominee and 1 EUA nominee.

On 20 June 2019 the panel issued the report *ENQA Agency Review: Italian National Agency for the Evaluation of Universities and Research Institutes (ANVUR)*. Globally, the panel considered ANVUR as being compliant with the European Standards and Guidelines, 2015 (ESG).

On 4 July 2019 the ENQA President formally notified ANVUR that "at its meeting of 20 June 2019, the Board of ENQA took the decision to grant ANVUR ENQA membership for five years from that date". In the same letter, the Board asked for a Follow-up report containing ANVUR's reactions to all the recommendations within a two-year period.

In order to continue fruitful exchanges with ENQA experts, ANVUR asked for a voluntary Progress visit. This was organised with the ENQA Secretariat and took place on 13 September 2021.

The present Follow-up report was drafted by a working group composed of Professor Antonio Felice Uricchio (President), Professors Marilena Maniaci and Menico Rizzi (Governing Board), Daniele Livon (Director), Alberto Ciolfi and Cecilia Bibbò (Officers); it was then discussed in plenary meetings with the other two members of the Governing Board, Professors Alessandra Celletti and Massimo Tronci, and shared with all the Agency's staff members, in order to collect their feedback. Preliminary drafts of the report were also presented to the Advisory Board of ANVUR in two meetings held on 13 July and 22 September 2021: this final version includes the feedback received by the Board's members. A preliminary draft of the report was included in the preparatory documentation of the Progress visit and was used as a basis for discussion with the experts.

The final version of the Follow-up report was discussed and approved by the ANVUR Governing Board in its meeting of 27 October 2021.

ENQA Board recommendations and ANVUR's follow-up

This report presents the recommendations of the ENQA Board and the responses of ANVUR through a number of actions taken since 2019 and planned activities due to be completed before the next external review (2024).

In particular, the Agency is making significant efforts to improve the procedures for the accreditation of institutions and programmes in the AFAM sector (higher education in arts, music, theatre and dance), and to develop specific QA standards, fully compliant with the ESGs. Concrete steps have also been taken to promote participatory assessment, with the greater involvement of students and external stakeholders. Ongoing work concerns the implementation of the ESG in the field of PhD programmes: this objective requires changes to the current legal framework (which should be made shortly) and the adoption of consequent regulations. Consequently, the Progress visit focused mainly on these two topics.

Already in **2019**, immediately after the Agency's accreditation, the Director and the Governing Board, with the support of staff from different areas, analysed the recommendations expressed by the ENQA Board in order to identify possible actions to be taken in following years to bring all the Agency's procedures fully into line with the ESG.

At the end of the analysis, and following internal consultations, specific actions were planned, referring in particular to:

- the revision of Guidelines for the accreditation of new study programs (see the Synoptic Table below);
- the revision of internal regulations;
- optimisation of internal organisation and processes;
- revamping of the Agency's website.

2020 was a very important year for ANVUR. In terms of governance, in January Prof. Antonio Felice Uricchio took over as the new President, and in April four new members of the Governing Board were appointed: Professors Alessandra Celletti, Marilena Maniaci, Menico Rizzi and Massimo Tronci.

A new Advisory Board was also designated in 2020, whose composition is defined by art. 11 of Presidential Decree 76/2010.

In 2020 the COVID-19 pandemic had a strong impact on the daily work of ANVUR, with all staff members having to resort to smart working. Moreover, the emergency had consequences on some

of the Agency's main evaluation procedures, such as the accreditation of institutions and study programmes of Universities and AFAM institutions and the cyclical research assessment procedure (VQR 2015-2019). In particular, site visits were conducted fully online, taking into account the advice provided by ENQA to Quality Assurance Agencies.

With regard to the university sector, all the on-site accreditation visits that had been planned for 2020 were postponed in one semester, resulting in no visits in the first semester of 2020, 11 visits in the second semester and 11 visits in the first semester of 2021. In order to avoid the application of different conditions within the same exercise, the same agenda used for in-presence visits was adopted for those held remotely, and a platform managed by ANVUR staff during the visit was set up to allow the creation of virtual meeting rooms. The first cycle of Institutional accreditation (97 universities) was completed in July 2021.

Regarding the AFAM sector, all site visits planned in 2020 for initial and periodic accreditation of AFAM Institutions and programs were carried out online, following the same agenda of the site visits. The assessment of infrastructures - which for some programmes in particular, represents one of the core aspects of "regular" site visits - was supported by the examination of videos prepared by the Institutions, in addition to a "virtual tour" arranged remotely.

In **2021** the Agency had new challenges to face, with profound changes coming in the economic, cultural, social and environmental spheres, speeded up dramatically by the recent pandemic. New issues were the possible evaluation of e-learning approaches and tools, the assessment of university placement policies and the effectiveness of initiatives in the fields of sustainability and active citizenship.

The publication of ANVUR's Biennial Report on Italy's higher education and research system, due to come out by Spring 2022, will have a very strong bearing on the organization of staff work. The Report will seek to provide policy makers (Academia, Ministry, Parliament and other stakeholders) with timely data, analysis and information (also making comparisons with other countries) to better target higher education and research policies. The publication of the new edition of the Report was put back from 2020 to early 2022 due to the COVID-19 emergency, in order to offer the most up-to-date picture and data, including the impact of the pandemic on Italy's higher education system.

Ongoing work also relates to other aspects of the Agency's activities, among which the revision of initial and periodic accreditation procedures for Universities and study programmes (for which a specific working group has been set up, involving all relevant stakeholders (Ministry representatives, rectors, faculty, students, administrative and technical staff).

Finally, ANVUR plans to re-apply for registration with EQAR in early 2022, after implementing the recommendations made by the Board in the 2019 review report.

Following the notification that ANVUR had been granted ENQA membership for five years, immediate discussions were held, and actions were taken and planned by the Governing Board to address all recommendations through specific actions over the following two years. As regards PhD programmes, the regulatory framework is currently still governed by Decree no. 45/2013 (http://attiministeriali.miur.it/media/211174/dm regolamento corsi dottorato.pdf). The need to update the Decree had already been recognised by ANVUR, and based on the specific recommendations of ENQA, the previous Governing Board had put forward a proposal for a new Decree aimed at regulating Ph.D. programmes in the Italian university system. The new Governing Board decided that the procedure needed further improvements to be fully compliant with ESG 2015. They approved a new proposal that was sent to the MUR (Ministry of Education) at the end of May 2021. The new text contains several novelties and responds in particular to a major recommendation by ENQA, establishing that the accreditation procedures for Ph.D. programmes will have to be defined following the European Standards and Guidelines, 2015 (ESG). At the time of writing, after consultations with major stakeholders (CRUI – Conference of Rectors, CUN – National University Council, ADI – Association of PhD students), a Ministerial Decree based on ANVUR's proposal will be released by the end of 2021, and could become operational for the next or the following accreditation cycle (2022-23 or 2023-24).

The following pages of this report provide a synoptic table listing all completed, ongoing and planned actions, from 2019 to 2021-22, aimed at fulfilling ENQA's recommendations. For every action/activity, the following information is provided:

- the relevant Standard;
- the text of the recommendation by the ENQA Board and, where applicable, further comments by the EQAR Board;
- the duration of the activity;
- a brief description;
- documents and/or web pages of reference.

A GANTT chart is added at the end, including all actions/activities presented in the synoptic table, with a reference number to identify them more easily.
